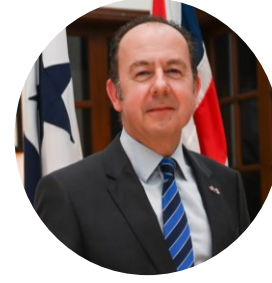

If approved, the candidates are then contacted for further steps to finalize their membership. Membership runs from 1 January to 31 December each year.

Members that join after 1 July will be charged a fee prorated to the amount of months remaining in the year.
